OPENING PRAYER

MADAM SPEAKER (N. RATTLE): Please be seated Honourable Members.

I would like to express my thanks to our Chaplain this afternoon for the beautiful message extended to us all and all the encouragement and his wishes to all of us for the Christmas and New Year festive season.

Kia Orana – greetings to all the Members of this House this afternoon. Today is a beautiful day and we look forward to the final day of our Sitting for this year.

Greetings to all our people listening in to our Parliament meeting today.

MADAM SPEAKER'S ANNOUNCEMENTS

Honourable Members, at 10.30 this morning I, with the Honourable Prime Minister, Henry Puna, Cabinet Ministers, accompanied by the Deputy Clerk, Jeannine Daniel delivered the Address in Reply to His Excellency, Sir Tom Marsters.

This is the Reply to the Speech addressed to Parliament at the Ceremonial Opening of the 49th Session of Parliament. His Excellency, Sir Tom Marsters was pleased to receive the Address in Reply from this dignified House.

He also extended seasonal greetings to each and every Member in this House and your families. I was also very pleased to see our Cabinet Ministers and Assistant Ministers who were present at the ceremony this morning. So, I thank you very much for a job well done in completing this job that was due to be done.

The second announcement I would like to make is that there has been an invite extended to Members of Parliament from the New Zealand High Commission for a Memorial Service for the late Her Excellency Tessa Temata. At 9.30 it will begin. So, if you are wanting to go please be seated before 9.30 this morning.

I also believe as indicated to me that your speeches to your constituencies this afternoon, your Christmas greetings will be ten minutes each Honourable Member.

So, we will begin with the Business of the Day.

First up today is our Question Time for 30 minutes.

QUESTION TIME

The Floor is now open for questions.

I beg your pardon. When we finished yesterday, you had the Floor, the Honourable Terepai Maoate and you may continue.

MR T. MAOATE: Thank you, Madam Speaker. Greetings to all of us this afternoon, and to our people listening in to Parliament.

My question this afternoon is posed to the Prime Minister. In fact, it is two questions. One is on the issue of foreigners married to locals under immigration laws. I posed this question in our last Sitting and I am just following it up, regarding the issue of Permanent Residence. I would like to extend my thanks to commend the Prime Minister for his time in Aitutaki. He met with the potential PR applicants. However, time has passed and they are now trying to follow up. As to what is happening and I have spoken to those in Immigration and there is no answer yet, to my inquiry.

My question on this is and I am told there is no cap for foreigners married to Cook Islanders. So, I would like the Prime Minister to explain where this lies?

And the second question is related to the Bill regarding foreign workers wanting to work in our country?

MADAM SPEAKER: Thank you. I see the Honourable Prime Minister.

HON. H. PUNA: Thank you Madam Speaker and thank you Honourable Member for Amuri/Ureia for raising this very important matter.

I am actually a bit embarrassed getting up to provide an answer to the question because I myself believe that the time is well overdue for something to be done decisively about this issue.

My embarrassment is compounded by the fact that as the Honourable Minister said, I did meet with four couples in Aitutaki to talk about their desire for things to be put on a proper footing for their partners who have been residents of the Cook Islands for quite a while. In all the terms of our PR policy, these people actually qualify to be granted Permanent Resident status. And I did tell them that I will do my best to expedite this status for them.

However, the concern from Immigration is that a new Legislation is actually almost finished and we need to wait for the Legislation to be in place. So, that we can treat all applications for PR and for work permits consistently and according to the same rules and as Minister Responsible for Immigration I was actually pushing for the new Immigration Bill to be presented to this Parliament.

Any Member can check with the Solicitor General and Crown Law Office how hard I was pushing for that Bill to be brought before this House. In fact, it was on my priority list and Government's priority list for presentation to this Parliament.

However, fairly late in the piece I was advised that the Bill would not be ready because on advice from the drafting office in Wellington. There were a few issues that they were not too happy about and they needed more time to make sure that everything was proper and consistent in the Bill.

So, that is why the Bill is not before the House this Sitting and that is why unfortunately Honourable Members, Members of this House the PR issues cannot be dealt with until the new Bill is in place. But I can guarantee this House that when Parliament sits again early in the new year, that Bill will be before Parliament and as soon as that Bill is passed, Honourable Member these applications will be processed promptly.

But thank you for not telling these people that we were going to be in Aitutaki yesterday because they did not come and bother me yesterday. But thank you for asking.

MADAM SPEAKER: Before I take your question Honourable Member; there was a question yesterday you asked that needs to be answered if I may ask the Minister Mokoroa to answer the question.

HON. V. MOKOROA: Thank you, Honourable Speaker and greetings to everybody this afternoon. I rise to answer the question raised yesterday with regards to the Police salaries.

We met this morning with the Secretary of Finance to go through the procedures for the pay rise. Firstly, the Financial Secretary explained that it is quite difficult going through the procedures of the Police salary.

Of course the Member of Parliament for Matavera understand the procedures as he has been through this as being Head of the Environment Ministry. Although there is an allocation for \$320,000 for this matter. However, there are several procedures that has to go through with applications and so forth. I am happy to tell this House that the Ministry of Finance, PSC and the Police are working together to sort these matters out before they deal with the rise in the pay for the Police Officers.

One of the areas to be dealt with is to pay the Police Officer from 1 July 2019. It has been found out from MFEM that 1.1 million is required for this purpose for the Police Department. That is why I mentioned earlier they are going through some difficulties in adjusting the Police salaries and increase but they are working hard to make sure that this is paid out by the end of this month.

Lastly, in the email from the Financial Secretary, I believe we are in a position to provide the data to Police for their review and to submit a proposal today. In my email to the Police Commissioner, the Financial Secretary and the Public Service Commissioner, I asked and I want to tell this House if this will be paid, today, tomorrow, next week or next year.

Therefore, I am happy with what the Financial Secretary said that the review of the salary increments for the Police will be completed and the Police Commissioner will finalise that before payment is processed sometimes this week or early next week. Thank you, Honourable, Speaker.

MADAM SPEAKER: Thank you, I see the Honourable Member, Vaitoti Tupa, you have the Floor.

MR V. TUPA: Thank you, Madam Speaker. Acknowledging to the Minister for your answer to the House of Parliament the reason being Minister because the staff of the Police who are not working this morning are listening in to the Sitting. I must say thank you to you and also the Prime Minister.

However, I have another question for you Minister of Internal Affairs. I am not quite sure how heavy or difficult or light my question is to you. However, we have a friend just returned back and I can recall that the same question was asked some years ago. He has lived here for five years and now he is sixty years old. My question here Minister is I am not quite sure whether to qualify for the pension is ten years. If that is the case, I have a request.

MADAM SPEAKER: Honourable Member, can you ask your question please then we will know what it is you want to know.

MR V. TUPA: This is the question whether this person will qualify to collect the pension, he has been here for five years. Thank you.

MADAM SPEAKER: Thank you and I see the Minister of Internal Affairs.

HON. V. MOKOROA: Thank you, Honourable Speaker and thank you to the Member for this good question. This question has been raised in the past and we are also aware there are many people in our districts going through the same problem. We are all aware under the policies whether you have lived in the Cook Islands for some time and you travel overseas for twenty years and when you return you have to live here for ten years before you qualify for the pension.

If you are married to a foreigner a non-Cook Islander, then you have to wait for twenty years before you qualify for a pension. These are the areas of difficulty for four people.

In the village of Nikao there is a gentleman, fifty-five years of age and he has lived in Rarotonga now for ten years. Although he will be sixty-five years in five years' time he will have to wait until then to be able to collect the pension. This should serve as an example to all of us because one day this will be related to your Constituency.

So, that is the request from the Member to review this Legislation because I believe it was passed in 1972. As I said in the last few days our pension scheme is under review and I believe it is appropriate this idea be included in the review today. So, if consultations come by your way to please get involved and let us look at whether we should change the Legislation or not to assist our people in this area in the future.

The gentleman in Nikao that I referred to is a former army member and he married his wife and he has lived here for some years. It is difficult for him to seek for a solution for his situation because he has to wait for 10 years before he qualifies for the pension.

I thank the Honourable Member for raising this good question. I also believe that this answer is appropriate for his question.

MADAM SPEAKER: Thank you and I see the Honourable Member, William Heather. Welcome back it is good to see you again.

MR W. HEATHER: Madam Speaker my question is directed to the Minister of Health. Yesterday we heard the Minister of Finance talking about the economic situation of our country which is good. We also heard the request by the Honourable Member for Mitiaro asking for a medical doctor for their island.

My question then for the Minister, has this matter been discussed in Cabinet and what has been done with the issue about having medical doctors on the Outer Islands. Has there been a decision made for some medical doctors to go to these islands and can you identify who these islands are.

MADAM SPEAKER: Thank you and I see the Minister Rose Toki-Brown and you have the Floor.

HON. R. TOKI-BROWN: Thank you Madam Speaker and Kia Orana to all Honourable Members of this House and to our people listening in to our broadcast. Now, I come back to the question. Yes, the Cabinet has discussed this matter and have not forgotten about it.

As you are aware we have started the flying doctors for the Outer Islands. And I would like to let this House know that we have covered our Outer Islands in the Cook Islands for this flying doctors and dentist program. We have nearly completed visiting all of the islands. Concerning the matter about permanent doctors for each of the Outer Islands.

We have problems in recruiting doctors to live permanently on the Outer Islands. We have tried and this is their response to the issue; it is too long for them to stay on the islands and because of the low population on the islands. The doctors are not in agreement with what we have been proposing to them to stay on the islands in the Outer Islands. The island of Aitutaki has a permanent doctor and for the rest of the islands we have Doctor Uka visiting these islands and other doctors also including dental doctors.

And the response from these islands, they are happy with the services that has been provided for them. But we have not forgotten the proposals that we find a permanent doctor for all the Outer Islands. We are still trying our best and I want you all to know because the Government did not want to send the doctors to one of the islands. We have discovered that some of the standards of these doctors are not good. We are therefore, trying to get doctors from New Zealand. Right now, Honourable Member we are trying our best to do this.

I trust I have given you a good response to your good question.

MADAM SPEAKER: Thank you and I see the Honourable Tamaiva Tuavera.

MR T. TUAVERA: Thank you, Madam Speaker. I have a quick question. My question yesterday was to the Minister Mokoroa regarding the \$34 level for poverty line and I believe your side stepped by this question yesterday.

You did not answer my question about the level of poverty line for caregivers, infirm and disabled because my calculation tells me that they are being paid \$6.57 a day. That is way below the poverty line and the question to you then is this. When will you be making the adjustment to this matter and is it going to be during your time.

MADAM SPEAKER: Thank you and I see the Minister of Internal Affairs.

HON. V. MOKOROA: Thank you, Honourable Speaker. I do not pass the ball away. The question that I take from yesterday is, given that we are to follow the benchmark by UNICEF when can we see an alignment of an increase from \$34 per day for caregivers, infirmed and the destitute. That was the question if I take it from yesterday.

And I think my answer was that we will put this as a part of the scoping exercise by the team that is doing the survey. The calculation that the Member has done working out by digits, I suggest that he gives that to the consultants when they come and visit next year.

MADAM SPEAKER: Thank you very much Honourable Members and that completes our Question Time. We will now go to – Orders of the Day.

ORDERS OF THE DAY

Orders of the Day, is the Cook Islands Investment Corporation Amendment Bill interrupted debate. The Floor is open for debate. I see the Honourable Vaitoti Tupa.

MR V. TUPA: Thank you very much Madam Speaker for the opportunity given to me to speak.

I would like to give my views on this five Bills before this House. What I see these five Bills they are trying to correct issues that has not been addressed. For example, the establishment of the Board and how many years the member can stay on it. We did our Opposition discussion this morning and we were all present. This is a positive thing to me because they are keen to contribute to this Bill.

We would like to thank the lawyer, Lloyd Miles for making time to come and explain to us about these Bills and including the Members of the Opposition to raise some good questions. That is when we received the clear understanding of these Bills. I now refer to the elections of the Board members to CIIC.

There is not much difference to me but it has identified what they are required to carry out in their duties and, in addition, for these Board Members to be appointed there are criteria that they need to meet and because of that I am satisfied that the amendments

that we are doing to the CIIC Bill are good and I do believe that the Minister of Finance is aware of these things and that is why he has brought these Amendments to the House.

I know in some of the Boards I understand there are no limits to their Terms of Reference but in these Bills we can see that there are limits for the terms that they can serve because I see in the Amendment not above three years. I also see in this amendment there is a term of twelve years for them to serve but because in the previous Boards that I know some of them have served for over twelve years. Through this it has been made robust that a maximum of twelve years. After this then you are out of the Board.

So, I would like to commend the Minister because he knows this is an area of issue within this. As I have mentioned before, those who will be on these Boards we know in the past it was like a guess who - we already know who is going to be on the Boards but under the new legislation it is clear that if you do not hold any qualifications or proficiency in this area, you should not be on the Board.

So, when I do consider the five Bills before us where these areas are being strengthened, that is why I expressed the notion that I have no issues with these amendments. The explanations given to us to amend this I support those.

However, in our consultation this morning there were some ideas that came through. The idea of remuneration for the Board Members. The notion of limiting Board Members not above seven. However, we should be aware of some of the provisions under this legislation especially for the new incentives. Hence, I give my full support to the new proposals. However, we should, over time, monitor these proposals that we put forward to Lloyd Miles as they are developed.

We also look at the notion of appointing those on the Board from outside of the country. Before I say we should give this careful consideration maybe it is time for a review of all those of us here in the country because when I look at all of us Members of Parliament, if we are no longer Members of Parliament I am sure we shall be suitable for these Boards.

However, Madam Speaker, what the Deputy Prime Minister has done in strengthening these legislations I have no problem with it as well as reviewing those who will be appointed to the Boards. And reviewing the five SOEs, CIIC provides oversight on these SOEs. I think this is highly appropriate with the terminology of watchdogs on the performance of these SOEs.

This is why I am happy about these amendments in these legislations.

Therefore, Madam Speaker, I repeat my full support for the amendments to these five Bills before the House.

MADAM SPEAKER: Thank you. And before I acknowledge our next speaker, I would like to welcome the CIIC CEO, Tamarii Tutangata who is in the House this afternoon.

I now give the Floor to the Honourable Member, Agnes Armstrong.

MRS A. ARMSTRONG: Greetings Madam Speaker, Honourable Members and those listening in today.

I stand to support this CIIC Amendment Bill 2019 and also the remaining four SOE Amendment Bills. The amendments stipulated in the Bills would seemingly cut out the “job for the boys” or “girls” syndrome that we have seen so often in the past. We need to stop this practice and ensure that the right person is appointed for the job, no matter their political affiliation or gender.

The new standards and criteria as outlined in the Amendments provided clear guidelines in how Board Members are to be chosen and these should be adhered to. Involving our younger and upcoming business people is also a great incentive for this generation to become involved in having a say with new ideas, innovative ways in the way forward.

Remuneration should be consistent across all Boards but to be fair we should pay accordingly for those that demonstrate better achievements. Performances of CEOs and Board Members will need to be better managed as we have seen excessive remuneration being paid for non-productive outcomes.

I would also like to see candidates from the Pa Enua involved on some of these Boards. We do have some good people out there and as we strive to work collectively for the betterment of all our people then why not. Thank you.

MADAM SPEAKER: Thank you Honourable Member and I see the Honourable Selina Napa. You have the Floor.

MRS S. NAPA: Thank you Madam Speaker and greetings to all of us in this House.

I would like to direct my thoughts to the five Bills before this House. I would say that there are many more things being discovered in Government Ministries so these extra Boards that will be established, I believe that they will have a lot of contribution to the way our Government is run. Even though my brother and my sister have given their thoughts on these Bills, I still insist that I will say my part in regards to the appointments of Board Members.

I would say that the CIIC Board is one of the strongest Boards in the work of Government and it appears that a lot of our people wants to get into the CIIC so that they can help with the governance. I want our people to hear that CIIC and the State Owned Enterprises – the State Owned they are answerable to the CIIC and the CIIC is answerable to Cabinet.

My only difficulty with these Bills before the House is the position of giving out to those from outside of our country. I would say that all of these Directors positions should be held by our people living here in the Cook Island because they are here with us. It appears to me that if we appoint outsiders from those living here we are saying that they are the only ones suitable to hold these positions and our people here are not.

I also see that a lot of our children are graduating from University and are working in Government Ministries and they are capable to do the work. So, they are the rightful people to hold this Board positions.

One of the other areas that I have difficulties that was explained. My difficulty is why are the Board Members living outside the Cook Islands get more than the ones resident here.

I hope and to what my sister had raised before that this appointment should not be buying of supporters. And may this not be a way for the Government to give those who have lost their seats to hold a Board position but if they fall within the criteria that is set out then maybe. I am not just directing these thoughts to the Government even for us in the Opposition we should be aware of this.

So, I would direct my thought to our Leader of the Opposition so when we get into Government in the next election we should consider what is outlined.

When you look at the appointment of five to seven Members of a Board, out of these SOEs there will be twenty-five Board Members to be appointed and that is just the minimum and the maximum will be thirty-five members. This small country of ours they have a lot of Board Members. And in considering that I can see that there will be more Board Members than us Members of Parliament.

Maybe our people are looking at reducing our Members of Representatives in the House and this is what we are trying to do to increase the Board Members and I think because our work load is increasing in Government we are doing things.

Finally, I would like to make reference to their term in office. For me I will say that the Directors are not to sit on the Board for more than twelve successive years. To me this term is too long because this term to me it appears that they can claim this is our seat and I would say that twelve-year term is too long because we need to have new ideas.

Like what my Honourable brother have said, it is like a bullet when it leaves the barrel it moves fast and then eventually it slows down. That's what happens to someone who will sit on this Board for twelve years. In the beginning they are vigorous, they are strong and eventually it fades away.

Like I said before we have a lot of good people coming through the ranks, always, all the time.

My final thought is directed to the data base that will be created so that we can appoint people from it. We have been asking how can our people get onto this data base? Whether it will be advertised or notices will be given out and application forms to be filled. What we have been told is that you will shoulder tap them.

(Minister interjects)

MRS S. NAPA: The Minister is saying scratch my back. So, if it is based on this idea that we shoulder tap someone or scratch their backs, how can we get a good collection of people on this data base. So, we will therefore wait for the reply from Government to see who are the rightful people who qualifies to be on this data base or are we still using this system of shoulder tap.

I am very happy to see all the amendments that is brought before the House, they are for a good purpose but what I wonder is whether we will exercise and put those acts into good practice. I would say that if we follow to the letter of the law then our people will not have any problems with it. So, those are my thoughts on the five Bills that is before this House.

MADAM SPEAKER: Thank you, Honourable Member and I see the Honourable Member Tina Browne, you have the Floor.

HON. T. PUPUKE BROWNE: Thank you Madam Speaker. Firstly, I would like to commend the Prime Minister for allowing us the time to rest Parliament to give us some time to have consultations of these five Bills before the House.

As explained before we had a good consultation this morning especially all the Members of the Opposition Democratic Party attended. And you can hear the usefulness of the consultations like this because everything was made clear on the five Bills before the House.

Next I am proud to support the comments of the Members of the Opposition before me. I believe those of you on the other side of the House listening to our comments, I believe you all know there is substance in what we are saying.

I will not repeat the comments; however, I have two issues to raise. Firstly, on the matter of appointing overseas Directors. I understand in some cases we do realise we do not have any person within the country qualified for these positions. My plea to Government is to consider this matter properly because it is my firm belief that we have people in the country suitable for position on these Boards. Let us not look down on our own because we want to develop the capacity of our own people in our country.

The other issue is that I just learned this morning or we learned that we could make our recommendation for somebody to be elected on these SOE Boards. So, my request to the Minister is if can ask you please request recommendations from us because I do have a list of people who I firmly believe are suitable and qualified to be on these Boards. If you do not ask me by the end of next week I will send you this list.

On that basis, I along with Members of the Opposition are happy to support the amendment to the Bill before the House. Please do not only consider those with the gold and green flag to be elected on these Boards. You are also bound to consider those with a blue and red flag. Thank you, very much.

MADAM SPEAKER: If there are no further speakers. I will ask the Minister Responsible to conclude the debate please.

HON. M. BROWN: Thank you very much Madam Speaker. Thank you for the support from the Members of the Opposition. And rightly so that the relevant officials were able to provide you with a quick briefing and a workshop on the amendments to this Bill. I had mistakenly thought that had already been done yesterday.

To just lay the concerns of the Members that have raised some of the specific points in this amendment Madam Speaker. I can assure the Members that what we are following is international best practice in terms of the membership of our Boards.

We have seen the impact of small boards with only three members and the weakness of the governance involved in these boards or the pressure being placed on the governance of these boards. By the same token we have seen the impact that having more people on the board has had in being able to provide more experience and more qualifications and more thinking to the governance of those boards that have up to seven members.

So, standardising the board memberships to a minimum of five and maximum of seven ensures that there is more people on the board that need to reach consensus on important governance decisions rather than concentrating that decision making to a few numbers.

In terms of the remuneration of the boards again we have taken into account international best practice and I know the investment corporation engaged the company called Strategic Pay, to determine what a fair and appropriate remuneration is for all our board members.

I am pleased and I know that our board members and chairs of our SOEs are very pleased that Investment Corporation under the guidance of one of our board members, Karen Rangi is conducting directors training for all our board members to help lift their level of governance on our boards.

I think it is a mistake to say that the overseas members that we have on our boards are brought on because we do not have anybody capable enough that is quite wrong. The reason why we have cast our net wide and brought in directors that reside overseas is to strengthen the governance capabilities of these boards.

Let us not forget Cook Islanders do not just live in the Cook Islands we have a huge population that resides in New Zealand and Australia with a lot of capabilities and a lot of experience in these particular fields of the SOEs.

And I am particularly pleased with a number of our new appointments from overseas who are adding value to these boards and I mentioned them yesterday. Rightfully increasing the number of boards or standardising the numbers on our boards will allow us to appoint more of our people that are capable and able to play a key role in the governance of our State Owned Enterprises.

I look forward to receiving the list from the Leader of the Opposition on potential candidates for board positions. Potential members that we may tap on the shoulder or scratch on the back.

So, Madam Speaker I think it is very clear to everybody that the amendments a quite standard across the boards they do lift the level of governance. Also let me be clear that the appointment of our board members for our subsidiary SOEs is done by the Investment Corporation.

I think Madam Speaker with those words that concludes my statements on these amendments. Thank you very much.

MADAM SPEAKER: Thank you, Honourable Minister. I will now put the Question and the Question is:

That the Bill be now read a Second time?

If I may make a couple of comments, please.

The Control of Prices Amendment Bill that is before us makes a number of much needed amendments to the Control of Prices Act of 1966. The Act provides for price controls to prevent exploitation of the public. It also establishes the Price Tribunal currently constituted by Fletcher Melvin as the President and Catherine Evans and Louis Enoka as Members.

This Tribunal currently controls the prices for petrol, diesel, LPG and white bread. Madam Speaker, the Control of Prices Act 1966 is showing its age and has not been amended in a long time. For example, it has penalty provisions that are designated in pounds sterling and also imperial measurements rather than metric measurements. In addition, the offences and penalty provisions are inconsistent throughout the Act and are so low as to have no deterrent value.

The Amendment Bill will make several changes to this Act. Firstly, the Bill will modernise the offences and penalties provision to make them more consistent. It will increase the maximum financial penalties and ensure they provide an appropriate deterrent. It will also bring the current imprisonment terms in line with the times.

The Bill will provide a regulations making power to deal with matters such as setting prescribed fines, the supply of information to the Tribunal, follow up requests if the information is not supplied and the powers to enter and search premises and seize documents.

The Bill will also increase the fines payable for the measurement of scales and other instruments and for certificates of verification so they are more cost reflective. The Bill will convert outdated imperial measurements into metric and the Bill will also provide a legal basis for the secretariat services recently transferred from Internal Affairs to the Ministry of Finance.

In conclusion, Madam Speaker, I commend this Bill before the House. This Bill will ensure that the Price Tribunal has 21st century powers and penalty levels. It needs to effectively do its job of protecting the Cook Islands community from price exploitation.

MADAM SPEAKER: I call for a Secunder to the Motion for the Second Reading.

Seconded by the Honourable Member, Patrick Arioka

And I see the Honourable Tina Browne. You have the Floor.

HON. T. PUPUKE BROWNE: Madam Speaker, the Opposition does not oppose the Bill. The Opposition recognises the need to bring ourselves into the 20th century given that this legislation was enacted way back in 1966.

The Opposition accepts that the penalties should be modernised as well but we would like to think that, that is the extreme - \$15,000 and \$60,000. That is the maximum. So, that when these matters come before the Court, the Court will obviously consider the difference between CITC and Turamatuitui Store.

My point here is that there should be some recognition in penalising any offenders under this amendment and the intention of the Bill as prescribed in the Bill, they are all for the good reasons and the Opposition supports this Bill.

Lastly, to all the Honourable Members in this House, all the staff of Parliament, new and old. Merry Christmas and a Prosperous New Year to us all. Kia Orana and Kia Manuia.

MR DEPUTY SPEAKER: Thank you, Honourable Member and I see the Honourable Member for Arutanga-Reureu-Nikaupara.

MR T. KAVANA: Kia Orana to the capital city of Aitutaki, Arutanga-Reureu-Nikaupara.

Greetings to all the different denominations in my constituency and there are 6 different churches in my electorate – Kia Orana to you all. Merry Christmas and a Happy New Year to you all. You are the servants of God and your prayers are for me and all the leaders of our nation; prayers of divine guidance so that our governance is for the benefit our people. Thank you very much to you and all your membership.

MRS A. ARMSTRONG: Tangi Ke, Tangi Ke, Tangi Ke rava. Kia Orana to the two Kavana, and to all the leaders and Ministers of the Gospel for all the different denominations in my constituency. All the Rangatira and Council members and all the people of Ivirua and the whole of Mangaia – greetings to you all.

I humbly thank each of you for your support and look forward to continuing to work closely together to make our village an even better place to live. My children and I extend to you all a Christmas bless with lots of love, fun, peace, joy and happiness.

To all my people on Auau enua; May you all have a very Merry Christmas. I look forward to the new year of working towards fulfilling our dreams and serving my people of Ivirua and our country. Wishing you all the best of health, happiness and prosperity for the New Year. May you realise your hopes and aspirations for 2020.

Deputy Speaker, Prime Minister, Deputy Prime Minister, my Leader and all Honourable Members of this Honourable House and your families, the staff of Parliament and your families and to all our people in our great nation. I wish you all a very Merry Christmas and Prosperous New Year. Be safe, love one another and be kind. God Bless you all.

MR DEPUTY SPEAKER: Thank you, Honourable Member from Ivirua and I see the Honourable Member from Nukuroa you have the Floor.

MR T. TANGATAPOTO: Deputy Speaker since my voice is not being heard by my people of Nukuroa. I consider it a waste of my time when I greet them but only the air will hear me and not my people.

It is better that I wait until I return to my island and I greet them face to face and give them my festive season greetings in person. However, I still want to say something to you all today. To the Prime Minister, Cabinet Ministers and all in Government and those in the Opposition, the Leader and all the Members of the Opposition. I would like to thank you all for your kind words and sincere encouragements for the time I was suffering with my foot injury.

The elderly older people, the widows – both men and women, the destitute and old and young – Kia Orana. MR T. TUAVERA: Here stands Vaka Takitumu, the Vaka Taunga, the Vaka Ariki of Tangia – i-e-ko-ko. You heard the head of the fish of Tangia deliver his speech and now you will hear the belly of the fish of Tangia talk to you.

Kia Orana to my people of Ngati-tangia, from Taura-roa to Rao-ia. I greet the three pillars of our village, our two chiefs, Pama Kainuku – Kia Orana, I know that you are not well hence you are overseas and not in our village. The Ui Mataiapo, Ui Rangatira, Ui Taunga, our elderly, youth and children – Kia Orana to you all. The many denominations in our village, LDS, SDA, AOG and CICC. We welcome our new appointed CICC Reverend Takaikura Marsters and your wife to our village church. We are saddened by our outgoing Reverend Tereora Viniki who is now transferred to Mangaia because he spent 8 years pastoring our Ngatangia CICC church, we pray the Lord will bless their ministry in Mangaia.

And to all the people that I have come into contact with over the years – Kia Orana to you all. And to Miss World Oceania, Tajiya Sahay, the Captain Tama girl, the world is your oyster girl – go for it. Remember yesterday is history, tomorrow is a mystery and today is a gift.

From my wife Lynn and my daughter Avaarii and my son Teariki to all of you that I have not mentioned, please accept my deepest apologies. Have a safe festive season with your families and friends – be safe, Merry Christmas and Happy New Year. May God Bless us all and even in this House, Madam Speaker, Deputy Speaker and to all the staff, Clerk, Deputy Clerk, Interpreters, Prime Minister, Deputy Prime Minister and our Leader of the Opposition and all Honourable Members. Thank you.

MR DEPUTY SPEAKER: Thank you Honourable Member, I now see the Honourable Member Tingika Elikana.

MR T. ELIKANA: Thank you Mr Deputy Speaker. I rise to move a Motion.

The greetings to the various sector of our island Mangaia. MR DEPUTY SPEAKER: Thank you Honourable Member. I see the Honourable Member Tingika Elikana.

MR T. ELIKANA: Kia Orana to all of us in the Name of the Lord. First of all, Kia Orana to you Madam Speaker and Deputy Speaker for the good leadership that you both applied in our House of Parliament. Thank you to the Clerk and Deputy Clerk and also to the Interpreters for your good work.

Greetings to all my people on Pukapuka and Nassau. Kia Orana to our Teuru Ariki, Tetio Kaisara Pa-ki-Tonga Paulo Ariki, and your family. All the island traditional leaders, all the people both old and young, I greet you all in the Name of our Lord.

I also greet our many churches on our islands of Pukapuka and Nassau, I encourage you to continue your good work for our people to remain faithful with God.

I greet the Government workers, the Mayor and Island Councillors and your families, continue to serve our people and our island well. The EO and your officers I greet you and thank you for your good work.

I now would like to thank and greet previous and retired Members of Parliament for Pukapuka that are still living, Papa Tiaki Wuatai and family, Papa Tamaiti Peua and family, Papa Tekii Lazaro and family.

I now greet the Tere Party from New Zealand and Australia that is to visit Pukapuka, I welcome you all back home. Again I thank you my people for trusting me to be your representative into this House of Parliament.

Lastly, I thank you my wife Tetuanui Takai for supporting me in this role that we are carrying at this stage of our lives.

Merry Christmas and Happy New Year to all. Thank you everyone.

MR DEPUTY SPEAKER: Thank you Honourable Member and I see the Honourable Member from Teimurimotia.

MRS S. NAPA: *[Member began her speech with a traditional chant].*

My Teimurimotia during this festive period has become the place to go to the beaches to swim for most of the people of Rarotonga. On behalf of Teimurimotia I welcome you all to visit our beautiful beaches during this time of the year and enjoy a swim with us.

Takitumu has a protocol to follow and it goes like this. If someone comes to Takitumu they have to come to the head of the fish first which is Matavera and then through the belly which is Ngatangiia and finally to the tail, which is my constituency of Teimurimotia. That is the reason I am the last Member from Takitumu to give my Christmas greetings because I am the tail of the fish.

I greet all the people of Teimurimotia, the traditional and business community, the religious sector and to all the people from the elderlies right down to our new born babies which includes our young people. My husband and I and our children convey to you all a Merry Christmas and Happy New Year best wishes.

This is the time when the youth of Titikaveka are very busy organising village programs and we would like to invite all of Rarotonga to a drug and alcohol awareness Christmas concert under the stars on Sunday at the CICC church grounds. The program will focus on ways to encourage our young people not to get into drugs and alcohol. And on Christmas Eve there is an open air concert and tomorrow there is a fundraiser for the wife of Papa Funigi for her medical needs at the Papaaroa SDA Hall. We are working hard in Titikaveka for the community as a whole to help each other with our needs.

Last night one of youth in Titikaveka passed away and a few week ago another youth also passed away. What shall we do for our youth? This is our Members of Parliament appeal to you all our young people. Do not be overcome by the senseless amusements of this world, please be careful of your actions, be not like the fools but like the wise.

To all of our people listening in to our parliament broadcast, Teimurimotia sends their Merry Christmas and Happy New Year greetings to you all.

Lastly to my Democratic Committee and supporters, and the Mama Bulldogs I thank you all for your strong support for our village people. Merry Christmas and Happy New Year to you all.

To our Leader of the Opposition, Mrs Tina Browne and all our Opposition Members, Merry Christmas to you all. From Teimurimotia – we love you all from the bottom of our hearts.

On the side of the Government, Kia Orana to the Papa Mayor and all the Island Councillors, the EO and all the Government workers on Akatokamanava – Kia Orana in the Name of the Lord. May the Good Lord Bless us all for the Christmas and the New Year.

I will be returning home this Thursday and we will meet together before the festive season. Please accept my words of greetings to you all. To all our visiting people from overseas – greetings to you all, may you have an enjoyable time on our island.

Again, May the Good Lord Bless us all for the Christmas and the New Year period. Kia Orana and Kia Manuia.

Secondly, I extend to you Madam Speaker our best wishes as you travel home to Manihiki tomorrow. Thank you for all your hard work for our Parliament during this year. May the Good Lord Bless us all for the Christmas and the New Year.
