- 1 Title**
These regulations are the COVID-19 (Public Health Measures) Amendment Regulations (No 3) 2022.
- 2 Commencement**
These regulations come into force on 1 April 2022.
- 3 Principal regulations amended**
These regulations amend the COVID-19 (Public Health Measures) Regulations 2021 (the principal regulations).
- 4 Regulation 4 amended (Interpretation)**
In regulation 4(1), revoke the definitions of **contact record, Cooksafe tag-in station, event, gathering, and regulated business or service.**
- 5 Regulation 6 revoked (Meaning of event)**
Revoke regulation 6.
- 6 Regulation 8 revoked (Meaning of gathering)**
Revoke regulation 8.
- 7 Regulations 15 to 17 and cross heading revoked**
Revoke the cross heading before regulation 15 and regulations 15 to 17.
- 8 Regulation 18 amended (Person must not provide false or misleading information or a document that does not belong to them)**
Revoke regulation 18(1)(a).
