Seabed Minerals Amendment Act  
2021

An Act to amend the Seabed Minerals Act 2019 to-  
(a) clarify that only companies incorporated in the Cook Islands and that are registered under the Companies Act 2017 may apply for a prospecting permit, an exploration or mining licence, or a sponsorship certificate; and  
(b) include transitional provisions for licence applications that have not yet been determined

Police Amendment Act 2021

An Act to amend the Police Act 2012 to remove compulsory retirement at the age of 60 for members of the Police

COVID-19 (Cook Islands National Superannuation Act 2021

An Act to mitigate the economic hardship resulting from measures taken to protect the Cook Islands from COVID-19 (Coronavirus Disease 2019) by temporarily lowering the rate for contributions to the National Superannuation Fund for employers who receive a business grant or wage subsidy under the COVID-19 Economic Response Plan after 31 March 2020, and their employees.
