Financial Transaction Reporting Act 2017	An Act to help combat financial misconduct and the commission of serious offences by monitoring certain transactions.
Marae Moana Act 2017	An Act to establish the marae moana within the waters of the Cook Islands and provide for its integrated management.
Crimes Act 2017	An Act to reform the criminal law of the Cook Islands and provide for related purposes
Financial Intelligence Unit Amendment Act 2017	An Act to amend the Financial Intelligence Unit Act 2015
