ORDER

1. Title and commencement – (1) This Order may be cited as the Cook Islands National Superannuation Fund (Category S1 Members) Order 2002.
(2) This Order shall come into force the day after the date that the Queen's Representative signs it.

2. Interpretation – In this Order–

“Category S1 Members” means–

- (a) The Airport Authority (established under the Airport Authority Act 1985); and
- (b) The Cook Islands Development Bank (established under the Cook Islands Development Bank Act 1978); and
- (c) The Cook Islands Tourism Marketing Corporation (established under the Cook Islands Tourism Marketing Corporation Act 1998); and
- (d) The Cook Islands Investment Corporation (established under the Cook Islands Investment Corporation Act 1998); and
- (e) The Ports Authority (established under the Ports Authority Act 1994-95); and
- (f) Te Aponga Uira o Tumu-Te-Varovaro (established under the Te Aponga Uira o Tumu-Te-Varovaro Act 1991); and
- (g) Every employee of an entity specified in any of paragraphs (a) to (f) who is–
 - (i) Employed in Rarotonga; and
 - (ii) Not a member of the Government Superannuation Fund (GSF).

3. Application of Act to Category S1 Members – The Cook Islands National Superannuation Act 2000 shall apply to Category S1 Members.
