- Title and commencement** – (1) This Order may be cited as the Cook Islands National Superannuation Fund (Category G1 Members) Order 2001.
(2) This Order shall come into force on 24 September 2001.

2. Interpretation – In this Order -

““Category G1 Members” means all public servants and Crown servants who are –

- (a) employed in Rarotonga; and
- (b) on the payroll administered by the Finance Division of the Ministry of Finance and Economic Management; and
- (c) not members of the Government Superannuation Fund (GSF); and their employers.”

3. Application of Act to Category G1 Members – The Cook Islands National Superannuation Fund Act 2000 shall apply to Category G1 Members.
