ORDER

1. Title and commencement – (1) This Order may be cited as the Cook Islands National Superannuation Fund Order (1) 2006.
(2) This Order shall come into force on 1 February 2006.
2. Interpretation – In this Order – the Categories refer to:
 - (a) “AE 001 members”, means all employees of Small Business Enterprise Centre;
 - (b) “AB 001 members”, means all employees of WESPAC Banking Corporation (Cook Islands);
 - © “AB 002 members”, means all employees of ANZ Banking Group Ltd (Cook Islands);

- (d) "AB 003 members", means all employees of Wall Street Banking Corporation Ltd;
- (e) "AT 001 members", means all employees of Southpac Trust Ltd;
- (f) "AT 002 members", means all employees of Zetland Trust (Cook Islands) Ltd;
- (g) "AT 003 members", means all employees of Trustnet (Cook Islands) Ltd;
- (h) "AT 004 members", means all employees of Cook Islands Trust Corporation Ltd;
- (i) "AT 005 members", means all employees of HSBC Trustee (Cook Islands) Ltd;
- (j) "AT 006 members", means all employees of ASIACITI Trust Pacific Ltd.

3. Application of the Act. The Cook Islands National Superannuation Fund Act 2000 shall apply to the following entities:

- (a) Small Business Enterprise Centre and its' employees;
- (b) WESPAC Banking Corporation (Cook Islands) and its' employees;
- (c) ANZ Banking Group Ltd (Cook Islands) and its' employees;
- (d) Wall Street Banking Corporation Ltd and its' employees;

- (f) Zetland Trust (Cook Islands) Ltd and its' employees;
- (g) Trustnet (Cook Islands) Ltd and its' employees;
- (h) Cook Islands Trust Corporation Ltd;
- (i) HSBC Trustee (Cook Islands) Ltd and its' employees;
- (j) ASIACITI Trust Pacific Ltd and its' employees.
