- 1 **Title**
This order is the Customs Tariff Amendment (No.2) Order 2014.
- 2 **Commencement**
This order comes into force on 1 July 2014.
- 3 **Principal Act amended**
This order amends Schedule 1 of the Customs Tariff Act 2012 (**the Tariff**).
- 4 **Part 1 of the Tariff amended (Chapter 24)**
The Tariff is amended by deleting chapter 24 and substituting the chapter in the attached Schedule.

Schedule 1 The Tariff

Chapter 24

Tobacco and manufactured tobacco substitutes

NOTE:

1. This Chapter does not cover medicinal cigarettes (Chapter 30).

SUBHEADING NOTE:

1. For the purposes of subheading 2403.11, the expression water pipe tobacco means tobacco intended for smoking in a water pipe and which consists of a mixture of tobacco and glycerol, whether or not containing aromatic oils and extracts, molasses or sugar, and whether or not flavoured with fruit. However, tobacco-free products intended for smoking in a water pipe are excluded from this subheading.
