- 5 Section 102 of the Principal Act**
The goods in chapter 99 of the first schedule to the Customs Tariff Act 2012 are specified goods for the purposes of section 102 of the Principal Act.
- 6 Subsection 106(1) of the Principal Act**
The goods in chapter 99 of the first schedule to the Customs Tariff Act 2012 are specified goods for the purposes of subsection 106(1) of the Principal Act.
- 7 Subsection 109(1) of the Principal Act**
The goods in chapter 99 of the first schedule to the Customs Tariff Act 2012 are specified goods for the purposes of subsection 109(1) of the Principal Act.
- 8 Subsection 110(1) of the Principal Act**
The goods in chapter 99 of the first schedule to the Customs Tariff Act 2012 are specified goods for the purposes of subsection 110(1) of the Principal Act.
- 9 Subsection 112(1) of the Principal Act**
The goods in chapter 99 of the first schedule to the Customs Tariff Act 2012 are specified goods for the purposes of subsections 112(1)(a) and 112(1)(b) of the Principal Act.
- 10 Rate of Excise Duty**
Excise duty is payable at the rates set out in chapter 99 of the first schedule to the Customs Tariff Act 2012 as amended, modified, evoked or replaced from time to time.
- 11 Subsection 2(2) of the Principal Act**
For the purposes of subsection 2(2) of the Principal Act, Part 9 and Schedule 3 of the Principal Act come into force on 1 July 2014.
