1. Short Title - This Order may be cited as the Customs Tariff (Alcoholic Beverages) Amendment Order 2000, and shall be read together with and deemed part of the Customs Tariff Amendment Order 1989 ("the principal Order").

2. Beverages, spirits and vinegar - Schedule 1 of the principal Order is amended by deleting from Section IV of Chapter 22, pages 11, 12, 13, 14, 15, 16 and 17 and substituting pages 11, 12, 13, 14, 15, 16 and 17 annexed hereto in the Schedule to this Order.

Section IV, page 11

Chapter 22**Beverages, Spirits and vinegar****Notes:**

1. **This Chapter does not cover:**
 - (a) **Sea water (heading no. 25.01):**
 - (b) **Distilled or conductivity water or water of similar purity (heading No. 28.51):**
 - (c) **Acetic acid of a concentration exceeding 10% by weight of acetic acid (heading no. 29.15):**
 - (d) **Medicaments of heading No. 30.03 or 30.04; or**
 - (e) **Perfumery or toilet preparations (Chapter 33).**
2. **For the purposes of this Chapter and of Chapters 20 and 21 the "alcoholic strength by volume" shall be determined at a temperature of 20 degrees.**
3. **For the purposes of heading No. 22.02 the term "non-alcoholic beverages" means beverages of an alcoholic strength by volume not exceeding 0.5% vol. Alcoholic beverages are classified in headings Nos. 22.03 to 22.06 or heading No.22.08 as appropriate.**

Subheading Note:

1. **For the purposes of subheading No. 2204.10, the expression "sparkling wine" means wine which, when kept at a temperature of 20 degrees in closed containers has an excess pressure of not less than 3 bars.**

Cook Islands Note

1. **Item 2204.1010 is to be taken to apply only to naturally carbonated white wine entitled to the appellation "champagne" by virtue of being the produce of the Champagne district of France.**
