PURSUANT to sections 49B and 51 of the Entry, Residence and Departure Act 1971-72 the Queen's Representative, acting by and with the advice and consent of the Executive Council hereby makes the following regulations:

REGULATIONS

1. Short Title and commencement - (1) These Regulations may be cited as the Entry, Residence and Departure Fees (Amendment) Regulations 1997, and shall be read together with and deemed part of the Entry, Residence and Departure Fees Regulations 1976 (hereinafter referred to as "the principal Regulations").

(2) Except for Part 2 of the Schedule, these Regulations shall come into force on the date they are assented to by the Queen's Representative.

(3) Part 2 of the Schedule shall come into force on 1 October 1997.

2. Fees payable by non-Cook Islanders married to Cook Islanders or Permanent Residents - The principal Regulations are amended by inserting after regulation 3, the following new regulation -

"3A. Fees payable by non-Cook Islanders married to Cook Islanders or Permanent Residents - Where a person is required to pay any fees pursuant to these Regulations and that person is legally married to a Cook Islander or a Permanent Resident, he or she shall pay fifty percent (50%) of the fees payable as set out in the Schedule to these Regulations."

3. New Schedule - The principal Regulations are hereby amended by revoking the Schedule and substituting the Schedule set out in these Regulations.
