**ORDER**

1. Title and commencement - (1) These regulations may be cited as the Liquor Licensing (Fee) Regulations 1991.  
(2) These regulations shall be deemed to have come into force on the 1st day of April 1991.
2. Interpretation - In these regulations, unless the context otherwise requires -  
"Act" means the Liquor Licensing Act 1988 and the Liquor Licensing Amendment Act 1990;  
"Authority" means the General Licensing Authority established by the General Licensing Authority Act 1989.
3. Application of regulations - These regulations shall apply to every premise required to have a liquor licence.

## *Sale of Liquor*

4. Application fees - Fees set out in the First Schedule to these regulations and corresponding to the type of licence applied for shall be payable to the Authority upon application being made for a liquor licence.

5. Annual licence renewal fees - Fees set out in the Second Schedule to these regulations and corresponding to the type of licence held shall be payable to the Authority annually by 1 April each year for the following year.

6. Extended hours fees - Fees set out in the Third Schedule to these regulations and corresponding to the type of licence held shall be payable to the Authority upon application being made for an extension of trading hours of the existing liquor licence.

7. Special licence fees - Fees set out in the Fourth Schedule to these regulations and corresponding to the type of licence applied for shall be payable to the Authority upon approval being made for a special licence.
