ORDER

1. Title and commencement – (1) This Order may be cited as the Cook Islands National Superannuation Fund (Category G2 Members) Order 2002.
(2) This Order shall be deemed to have come into force on 1st January 2002.

2. Interpretation - In this Order –

“Act” means the Cook Islands National Superannuation Fund Act 2000;

“MFEM” means the Ministry of Finance and Economic Management;

“Category G2 Members” means all Outer Islands based Government and Crown employees whose payroll is administered by the MFEM Finance Division and who are not members of the Government Superannuation Fund (GSF); and their employers.

3. Application - The Act shall apply to all Category G2 Members.
